1. Information We Collect

We collect personal information in two ways:

A. Information You Provide

We do not use this information for advertising, retargeting, or selling to third parties.

B. Information Automatically Collected

We collect standard technical and analytic data, including:

- IP address (anonymized or truncated where feasible)
- Browser type and device information
- Operating system
- Pages visited and time spent on the Website
- Referring website or search engine
- Click behavior and navigation patterns

This data is collected through first-party cookies and privacy-centric analytics tools.

We do not use:

- Cross-site tracking
- Advertising cookies
- Targeted ads
- Social media retargeting pixels

2. How We Use Personal Information

We use collected information to:

A. Provide & Improve Website Experience

- Respond to your messages or requests
- Communicate about tenant space, facility information, or events
- Improve Website functionality and performance
- Maintain Website security and reliability
- Analyze how visitors interact with the Website

B. Ensure Security & Legal Compliance

- Detect and prevent fraud, abuse, or unauthorized activity
- Comply with legal obligations and regulatory requirements
- Maintain operational logs and access controls

We do not use personal information for advertising, profiling, or automated decision-making.

3. How We Share Information

We share information only in limited, responsible ways:

A. Service Providers

We may provide data to third-party partners who help us operate the Website, such as:

- Hosting providers
- Security and performance vendors
- Basic analytics services
- Email and form-submission tools

They may only use your information to perform their services and are **contractually prohibited** from selling or using it for advertising or marketing.

B. Legal Requirements

We may disclose information when required to:

- Comply with applicable laws and regulatory obligations
- Respond to lawful governmental or law enforcement requests
- Protect rights, safety, property, or the public

C. Business Transfers

If Shadelands SportsMall undergoes a merger, acquisition, restructuring, or asset transfer, personal information may be shared under confidentiality protections.

We **never** sell personal information.

4. Cookies & Tracking Technologies

The Website uses minimal, privacy-focused cookies, such as:

- Functional cookies (required for site operation)

We **do not** use cookies for advertising or behavioral tracking.

You may disable cookies via your browser settings, though some features may be affected.

5. Data Retention

We retain personal information only as long as necessary to:

- Respond to inquiries
- Support operations
- Meet legal or regulatory obligations

When the information is no longer needed, it is securely deleted or anonymized.

6. Your Rights Under California & U.S. Privacy Laws

We do **not** sell or share personal information for cross-context behavioral advertising.

Right to Limit Use of Sensitive Personal Information

We do not collect or use sensitive personal information.

Right to Non-Discrimination

You will not be treated differently for exercising privacy rights.
